



SUBJECT: Final Report – FY09 Master Sergeant Selection Board

1. In accordance with DA Memorandum, DAPE-MPE-PD, dated 3 June 2008, Subject: Memorandum of Instruction for the FY09 Master Sergeant Selection Board, a board of 19 officers and 53 noncommissioned officers convened at Indianapolis, IN 46249-5301 at 1230 hours on 5 August 2008, to select the best qualified individuals from the zone of consideration to perform the duties and assume the responsibilities of the next higher grade.
2. The board, acting under oath and having in view the special fitness of the enlisted personnel and the efficiency of the Army, has carefully considered the records of every noncommissioned officer submitted to it for consideration. Guidance received by the board was executed with care.
